



## 6. General Business:

### 6.1 Literature – Starter Packs and other (ongoing from previous meetings)

As requested at December 2019 meeting, Anne contacted GSO and received a breakdown of the contents of the Yellow (starter), Green (correctional) and Blue (hospital) wallets and the cost GSO charges for the complete wallets. A comparison of the contents and costs of GSO wallets vs Perth wallets are:

#### Perth CSO

##### **Yellow Wallet (starter)**

Total actual cost: \$3.77  
Sale price: \$2.85  
Number of pamphlets/cards: 9

#### Sydney GSO

##### **Yellow Wallet**

Total cost: \$2.85  
Sale price: \$3.00  
Number of pamphlets: 5

##### **Green Wallet (correctional)**

Total actual cost: \$4.92  
Sale price: \$4.00  
Number of pamphlets/cards: 6

##### **Green Wallet (correctional)**

Total cost: \$4.42  
Sale price: \$4.50  
Number of pamphlets: 4

#### **Yellow Wallet**

Following a review of the contents of the Yellow starter pack, it was decided to remove “Making a Start in AA” from the wallet. It was agreed that the remaining contents of the wallet provided newcomers with adequate information on AA and the program. The cost of the Yellow starter pack would be increased to \$3.00, effective from March 2020. The removal of the one pamphlet means that it will not be necessary to increase it to \$3.80 to cover actual cost.

#### **Green Wallet**

The committee decided that the contents of the Green Wallet (correctional) should be referred to Areas for review by the Prison Representatives. If they wished to retain all of the pamphlets and cards currently in the wallet then the price would need to reflect the actual cost, ie \$5.00 per wallet.

***Action: Barbara to send Areas A and B notification of the price comparisons for CSO vs GSO for the Green Wallet (correctional) and the actual cost of the contents, and request that a review be conducted by Areas for contents and pricing purposes.***

### 6.2 Changes to Signatories to Bank Account

- Patricia L (CSO Volunteer) resigned from CSO on 31 December 2019.
- Julian A R has been appointed as her replacement with effect on 1 January 2020.
- As a result of the change Julian A R is to be added as signatory to the CBA bank account and Patricia L is to be removed.

**Motion:** That Julian AR is to be added as a signatory on Commonwealth Bank of Australia account number 61101039754 and Patricia Jean L be removed as signatory to the account. Authority to include Netbank.
